Likewise, the Company just received the information that the Rehabilitation Court, Regional Trial Court of Bulacan Branch 7 issued an order on February 18, 2011, ordering the issuance of a writ of execution against Philippine Charter Insurance Corporation mandating it to pay Vitarich Corporation the sum of P150 million pesos as partial payment of the Corporation's claim of P320 million pesos which it incurred from the floods brought about by typhoon "Ondoy" on September 26, 2009.
