## **Item 9. Other Events**

The Regional Trial Court of Bulacan, Branch 15 issued an Order dated August 13, 2015, received by Vitarich today, ordering Vitarich to pay the full docket fee on its complaint against Charter Ping An Insurance Corporation, formerly Philippine Charter Insurance Corporation for P316 million plus 24% interest per annum from March 2010. The complaint involves Vitarich Corporation claim from the then Philippine Charter Insurance Corporation for the loss/damage of Vitarich's raw materials, stocks, machineries, equipment, buildings and plants caused by floods brought about by Typhoon Ondoy in September 2009... The order states that before the court can acquire jurisdiction over the claim, Vitarich should pay the docket fee.
